

Amendments to maps

1. Map 2, Sheet 31 of Maps – Volume 1 Inner Islands be amended to change the symbol used for scheduled item 31-19 on Browns Island from a black square to a pink square.
2. Map 2, Sheet 16 of Maps – Volume 1 Inner Islands be amended to remove item 16-3 in its entirety.
3. Map 2, Sheet 7 of Maps – Volume 1 Inner Islands be amended to remove archaeological item 7-7 in its entirety.
4. Map 2, Sheet 9 of Maps – Volume 1 Inner Islands be amended to remove archaeological item 9-6 in its entirety.
5. Map 2, Sheets 8 and 9 of Maps – Volume 1 Inner Islands be amended to refine the boundaries of archaeological item 9-10 to council land on the foreshore.
6. Map 2, Sheet 7 of Maps – Volume 1 Inner Islands be amended to show the correct boundaries of map reference 7-5 that are consistent with the surveyed boundaries as identified by Clough and Associates and shown on DP 331964 as protected areas 'BC' and 'BD'.
7. Map 2, Sheet 32 and 33 of Maps – Volume 1 Inner Islands be amended to reduce the boundaries of map reference 33-3.
8. Map 2, Sheet 16 of Maps – Volume 1 Inner Islands be amended to reduce the boundaries of map reference 16-1.
9. Map 2, Sheet 7 of Maps – Volume 1 Inner Islands be amended to reduce the boundaries of map reference 7-9.

Amendments to appendix 1a

1. Appendix 1a, map reference 23-21 be amended to change the reference to 'Kauri slide' to 'Log chute'.
2. Appendix 1a be amended to remove map reference 16-3 in its entirety.
3. Appendix 1a be amended to remove map reference 7-7 in its entirety.
4. Appendix 1a be amended to remove map reference 9-6 in its entirety.
5. Appendix 1a, map reference 9-10 be amended to refine the boundaries of this item to the council land on the foreshore.
6. Appendix 1a, map reference 9-3, description of the item be amended to state: Cemetery (private) (3).
7. Appendix 1a, map reference 7-5 be amended to show the correct boundaries of map reference 7-5 that are consistent with the surveyed boundaries as identified by Clough and Associates and shown on DP 331964 as protected areas 'BC' and 'BD'.
8. Appendix 1a be amended to reduce the boundaries of map reference 33-3.
9. Appendix 1a be amended to reduce the boundaries of map reference 16-1.
10. Appendix 1a be amended to reduce the boundaries of map reference 7-9.
11. Appendix 1a, paragraph 1 in section 3 be amended to state:
All archaeological sites in New Zealand are protected under the Historic Places Act 1993, whether scheduled or not, and any activity which proposes to damage, destroy or modify any archaeological site must be granted authority by the New Zealand Historic Places Trust. ~~whether listed or not.~~

It is noted that some of the above recommendations may result in the scheduled site surrounds requiring amendment.

Amendment to clause 7.15

1. The definition of scheduled site surrounds in clause 7.15 be amended accordingly to state:
Includes ~~all the land on which a scheduled item (or group of items) is located, and~~ all land within a defined area around the scheduled item(s), as illustrated in the diagrams in appendix 1 – Heritage schedules for the inner islands and appendix 2 – Heritage schedules for the outer islands. Site surrounds includes all those things, such as (but not limited to) land, trees, gardens, buildings and structures that are part of the heritage significance of the place and are located within the site surrounds.

The site surrounds are identified to protect the context of an item (or items) from effects that detract from the inherent heritage significance and value of the scheduled item.
